#### Certification of Compliance by Lending Institution

For the purposes of complying with the provisions of the Kansas Housing Loan Deposit Program, created by K.S.A. 2009 Supp. 75-4276 et. seq, the undersigned lending institution certifies the following:

1. The lender has received written certification from each developer/borrower evidencing their eligibility for this program.
2. The lender has approved the Housing Loan Deposit Program loan package submitted by each developer/borrower based on its internal guidelines of creditworthiness.
3. The lender has no other Housing Loan Deposit Program loan, made pursuant to this program, outstanding to any developer/borrower listed herein.
4. Upon placement of the Housing Loan Deposit Program deposit with the lender, the lender will fund the loan(s) to each approved developer/borrower as hereinafter agreed.
5. Per KAR 3-3-2, the State reserves the right to request written verification of the final appraised/sale price of all homes built under this program.

The lending institution hereby agrees to lend an amount equal to the Housing Loan Deposit Program to each eligible Housing Loan Deposit Program developer/borrower herein named at an interest rate which is not more than 4% above the interest rate on the Housing Loan Deposit Program as determined under K.S.A.2009 Supp. 75-42-80. Such interest rate shall be recalculated on the first business day of January and July each calendar year using the market rate then in effect.

The lending institution hereby agrees to reduce the Housing Loan Deposit Program balance in an amount equal to any payment of loan principal received from the developer/borrower.
