Project Overview

The City of Salina seeks funding from the U.S. Department of Transportation) for funding available through the Safe Streets and Roads for All (SS4A) program for their West Crawford Demonstration Grant Project which includes reducing four traffic lanes to three, adding a buffer for pedestrian and bicycle traffic, and installing pedestrian crossings with flashing beacons and bump-outs.

This opportunity is a discretionary BIL program with a local match requirement of 20% of the total project cost. The entity is requesting \$28,500.00 from the Build Kansas Fund, and is providing a local match of \$1,500.00. This request has the potential to unlock \$120,000.00 in federal funds, for a total project cost of \$150,000.00.

The deadline is June 26, 2025, and this Build Kansas Fund application was received on May 23, 2025.

Describe your efforts The City of Salina has actively pursued multiple funding opportunities to to find other available support this safety project and maximize available resources. funding sources for this project: In April 2025, City staff met with representatives from the Kansas

In April 2025, City staff met with representatives from the Kansas Department of Transportation (KDOT) Infrastructure Hub to determine eligibility for state-level matching grants. In that meeting, the Hub Technical Assistant provided support for the application process and encouraged us to apply.

Additionally, we are leveraging funds from the Bipartisan Infrastructure Law (BIL) Safe Streets and Roads for All (SS4A) grant program, which covers 80% of the project cost. The remaining 5% of the local match will be provided by the City of Salina using existing funds allocated for road improvement.

This approach layering federal, state, and local sources, demonstrates our proactive strategy to minimize the financial burden on the City while still achieving critical safety improvements. Staff have reviewed other funding mechanisms and determined that this combination provides the most cost-effective and timely support for this demonstration project.

We remain open to future opportunities for grant stacking or complementary funding to expand the scope of this project if additional sources become available.

Executive Summary – City of Salina SS4A Grant Application

The City of Salina, Kansas has been working since 2022 to develop a Comprehensive Safety Action Plan (CSAP) aimed at improving safety on our streets for all users. In partnership with KDOT and with the support of Toole Design Group, we are identifying high-risk and high-injury areas across Salina. This plan is expected to be approved by summer 2025 and will position the City to pursue major federal funding opportunities for implementation.

One of the highest priority areas identified through the planning process is the **Crawford Street Corridor**, carrying upwards to 12,000 to 15,000 vehicles per day. Between 2018 and 2023, this corridor has seen high percentages of Salina's rear end and angle crashes resulting in multiple injuries in addition to 20% of the city's pedestrian and bike injuries.

To address this, the City is proposing a demonstration project on West Crawford from Plaza Drive to 9th Street.



The project includes:

- Reducing four traffic lanes to three (one lane in each direction and a center turn lane),
- Adding a 6-foot buffer for pedestrian and bicycle traffic,
- Installing three pedestrian crossings with flashing beacons and bump-outs to improve safety and calm traffic.

Currently, this ³/₄ mile section of the Crawford Street Corridor is the highest safety priority according to crash data developed within the CSAP. This is largely due to the lack of a center turn lane, back of curb sidewalks, no mid-block crossings, and a high-volume of pedestrians and bicyclists interacting with high traffic volume. Furthermore, should the project prove successful, these improvements will be considered for further expansion to the west and east sides of this section.

The project will be run as a two-year trial to gather data on traffic volumes, speeds, and crash rates. Upon approval of the City's CSAP and results of this demonstration's data determining significant safety improvement, the City of Salina would apply for BIL SS4A implementation funds to make these improvements permanent.

The City is requesting **\$150,000** in BIL SS4A demonstration funds to support pavement marking changes, signage, flashing beacons, temporary bump-outs, and public education focused on pedestrian and bike safety. The required 20% local match will be split between the City (5%) and a KDOT matching grant (95%), limiting the City's cost to **\$1,500**, which will be covered by existing street improvement funds.

This project is a strategic, low-cost way to make City streets safer, more walkable, and more communityfriendly, aligning with federal goals around Complete Streets and Vision Zero. This investment will have a long-lasting impact in reducing crashes and injuries in one of Salina's highest injury corridors.
