#### **Project Overview**

The Norton City/County Economic Development seeks funding from the U.S. Department of Transportation for funding available through the Safe Streets and Roads for All (SS4A) program for their Northwest Kansas Safe Streets and Roads for All Project Action Plan project which includes developing a Comprehensive Safety Action Plan for a five-county region in Northwest Kansas to reduce fatalities and serious injuries.

This opportunity is a discretionary BIL program with a local match requirement of 20% of the total project cost. The entity is requesting \$150,000.00 from the Build Kansas Fund, and is requesting an exemption from the local cash contribution requirement. This request has the potential to unlock \$600,000.00 in federal funds, for a total project cost of \$750,000.00.

The deadline is June 26, 2025, and this Build Kansas Fund application was received on June 2, 2025.

## Project Title: Northwest Kansas Safe Streets & Roads for All Project Action Plan

## **Executive Summary:**

Norton County, Kansas, in collaboration with Graham, Phillips, Rawlins and Rooks Counties, seeks Safe Streets for All (SS4A) funding to develop a Comprehensive Safety Action Plan aimed at eliminating roadway fatalities and serious injuries across a five-county region in northwest Kansas. This plan will serve as the foundation for a Safe System-based approach to transportation planning, ensuring that all road users, especially vulnerable users such as pedestrians, bicyclists, and transit riders, can travel safely.

The Action Plan will identify high-risk corridors, assess systemic safety issues, and incorporate community-led solutions to create equitable and data-driven strategies. Completion of the plan will position the Norton County coalition to pursue SS4A Implementation Grant funding and leverage state and federal resources to reduce traffic violence.

### Scope of Work:

The Northwest Kansas Safe Streets & Roads for All (NWKSS4A) project will develop a comprehensive, publicly available, evidence-based Comprehensive Safety Action Plan. The Action Plan will include strategies to implement the Safe System approach for a five-county region in rural Kansas. The five-county area includes the counties of Graham, Norton, Phillips, Rawlins and Rooks and encompasses over 4,647 square miles in northwest Kansas. Norton County will serve as the fiscal agency for the project and will follow the County's standard procurement procedures to select an engineering firm for the project. The Action Plan will include the following components:

- Crash Data Analysis: Identify trends, risk factors, and systemic issues using five years of crash data.
- **Equity Mapping**: Overlay crash data with socioeconomic indicators to identify priority communities.
- **Public and Stakeholder Engagement**: Conduct workshops, surveys, and focus groups, with targeted outreach to underrepresented groups.
- **Policy and Infrastructure Review**: Assess existing programs, roadway design standards, and enforcement practices.
- **Project and Policy Recommendations**: Develop a prioritized list of actionable, fundable strategies based on effectiveness, equity, and feasibility.
- **Performance Metrics**: Establish benchmarks for progress monitoring and continuous improvement.

## Need for the Project:

The Fatality and Injury Report System Tool (FIRST) indicates the five-county region has an average annual fatality rate of 25.4, well above the national average annual rate of 12.0. The region includes several US and State Highways, as well as numerous county roads. The east-west routes, US Highway 24 and US Highway 36, connect rural communities in the northernmost part of the state and serve as Interstate 70 alternate routes. US Highway 183 and US Highway 283 are north-south routes, spanning the state from the Nebraska to the Oklahoma borders. State highways in the region include K-383 & K-9 (Norton, Phillips); K-18 (Graham, Rooks); K-84 & K-85 (Graham), K-117 and K-25 (Rawlins). Each county within the region has applied for the

Kansas Department of Transportation's High Risk Rural Roads Program, a federal-aid initiative aimed at enhancing safety and reducing crash rates on rural roads. Despite localized safety improvements, the five-county region lacks a unified, comprehensive safety action plan aligned with U.S. DOT's Safe System approach. The Action Plan funding is essential to build local capacity, unify fragmented efforts, and establish a roadmap that will guide future investments in infrastructure, education, enforcement, and policy change.

#### Partnerships and Collaboration:

The project will be led by Norton County in collaboration with:

- Graham, Phillips, Rawlins and Rooks Counties
- Public Works / Transportation / Police Departments in each county
- Local school districts and public health departments
- Community-based organizations
- Regional MPO and transit agencies

These partners will serve on a Safety Advisory Committee to guide the development of the plan.

#### **Project Outcome and Benefits:**

Deliverables will include:

- A federally compliant Comprehensive Safety Action Plan
- An interactive crash and equity analysis dashboard
- A prioritized project list for future grant applications
- Increased community capacity to engage in traffic safety planning

Long-term benefits include reduced fatalities, safer travel options, improved health outcomes, and greater equity in transportation investment.

#### **Budget and Timeline:**

Requested SS4A Grant Funding: \$600,000 Local Match: \$150,000 Total Project Cost: \$750,000 Timeline: 24 months following award announcement

#### **Commitment to Implementation:**

Following the completion of the Action Plan, the Norton County coalition is committed to:

- Applying for the SS4A Implementation Grant
- Integrating safety strategies into capital improvement and transportation plans
- Continuing community engagement in safety planning and project delivery

The Comprehensive Safety Action Plan is a critical step in transforming the current northwest Kansas transportation system into a system rooted in a Vision Zero philosophy, with a commitment to eliminating traffic fatalities and serious injuries in the region.
