Project Overview

The Shawnee County Sheriff's Office seeks funding from the U.S. Department of Transportation for funding available through the Safe Streets and Roads for All (SS4A) program for their Critical 911 and Real Time Crime Center Updates project which includes improving roadway safety and emergency response times through a countywide pilot that integrates upgraded 911 systems, real-time monitoring, and drone deployment.

This opportunity is a discretionary BL program with a local match requirement of 20% of the total project cost. The entity is requesting \$950,000.00 from the Build Kansas Fund, and is providing a local match of \$50,000.00. This request has the potential to unlock \$4,000,000.00 in federal funds, for a total project cost of \$5,000,000.00.

The deadline is June 26, 2025, and this Build Kansas Fund application was received on June 3, 2025.

Project Overview

Shawnee County, Kansas, serves over 19,317 residents in rural communities across approximately 556 square miles. The county faces significant roadway safety and emergency response challenges that need technology-driven solutions. In 2024 alone, 13 individuals lost their lives in vehicle crashes within the county. The Shawnee County Emergency Communications Center (SCECC) handles approximately 320,000 calls annually and dispatches around 190,000 of those calls.

To address these challenges, Shawnee County seeks \$5.0 million through the Safe Streets and Roads for All (SS4A) Demonstration Grant to implement a coordinated, countywide traffic safety pilot program. The proposed initiative includes modernization of the county's 911 dispatch infrastructure, expansion of the existing Real Time Crime Center (RTCC), and deployment of a drone-as-first-responder program, supported by a centralized drone hub.

These integrated enhancements will improve real-time detection of roadway incidents, strengthen multi-agency coordination, and ensure faster, more effective emergency response during the most critical minutes. Together, these efforts represent a proactive,

technology-forward strategy to improve roadway safety outcomes and save lives in Shawnee County.



Pilot Focus Areas

- Real Time Crime Center (RTCC) Upgrade: Shawnee County will expand and enhance its existing RTCC to better support traffic safety. This includes adding high-resolution traffic cameras, mobile camera trailers, automatic license plate readers (ALPRs), and AI-driven video analytics to improve incident detection and monitoring.
- 2. 911 Dispatch and Radio Network Modernization: Funding will support hardware and software upgrades for the county's 911 dispatch systems and 911 emergency radio network system, including new Computer-Aided Dispatch (CAD), Geographic Information System (GIS) mapping, and Automated Vehicle Location (AVL) tools. These upgrades will improve incident triage, resource deployment, and live coordination with the RTCC and field responders.
- 3. **Drone Deployment & Hub:** The county will establish a secure drone hub and deploy a fleet of drones to provide rapid crash site verification, aerial traffic assessment, and real-time video streaming to the RTCC. Drones will also support situational awareness in rural or infrastructure-limited areas.

Equity and Safety Priority

Demonstration corridors will be selected based on traffic crash, injury data and public safety response times. The project will incorporate community input and feedback throughout implementation and evaluation to ensure inclusive design and equitable impacts.

Key Outcomes

- $\geq 20\%$ reduction in emergency response times in pilot corridors
- Expanded real-time data sharing between RTCC and 911 operations
- Measurable safety improvements in high-crash and rural areas
- Stronger coordination across law enforcement, EMS, and traffic management

Evaluation Strategy

Shawnee County will partner with a third-party evaluator to track performance across a range of metrics, including system uptime, average response times, crash outcomes, dispatch efficiency, and public satisfaction. Evaluation findings will shape the County's long-term SS4A strategy and provide scalable directions for other jurisdictions.

Total Federal Request: \$4,000,000

Total Non-Federal Match: \$1,000,000-We have applied to the Build Kansas Fund to assist in covering the non-federal match.

1. Personnel – \$250,000

To ensure effective implementation, coordination, and accountability across all components of the SS4A pilot initiative, Shawnee County will designate a full-time Demonstration Project Administrator, housed within the Shawnee County Sheriff's Department. This position is budgeted at \$125,000 per year for two years (including full benefits), totaling \$250,000 over the grant period.

This position will serve as the central liaison between departments—including the Real Time Crime Center (RTCC), the 911 Communications Center, drone operations, and the SS4A evaluation partner—as well as the U.S. Department of Transportation.

Key Responsibilities:

- Oversee day-to-day implementation of the pilot across RTCC, 911, and drone components
- Serve as the primary point of contact with USDOT, the independent evaluation contractor, and community stakeholders
- Facilitate interagency meetings, track action items, and incorporate feedback into pilot operations
- Monitor project budgets, timelines, procurement processes, and contract deliverables

- Support compliance with SS4A reporting requirements and maintain detailed project documentation
- Coordinate public engagement and communications related to the pilot program

This administrator will play a critical role in ensuring that all elements of the demonstration project remain integrated, on schedule, and outcome-focused, while also fostering transparency and collaboration across departments and partners.

- New dispatch workstation hardware
- GIS-enabled routing and real-time situational mapping tools

c. Drone Program & Hub – \$930,000

- Drone fleet purchase (crash response-ready, thermal/night vision-capable)
- Drone as First Responder Program
- Secure launch and landing hub infrastructure
- Drone management and video transmission software
- FAA compliance tools, tracking, and insurance

3. Contracts & Services - \$970,000

• Third-party project evaluation: \$300,000

Independent assessment of safety outcomes, response time improvements, and equity impacts using crash data, CAD logs, drone telemetry, and RTCC records.

• Technology integration, maintenance, and IT support: \$570,000

Includes setup, cybersecurity protocols, system interoperability, and ongoing tech support for RTCC, drones, and 911 dispatch systems.

• Community engagement and stakeholder facilitation: \$100,000

Outreach and engagement with residents includes workshops, surveys, and design input for project implementation and evaluation.

4. Training – \$150,000

- Drone pilot certification, RTCC operator training, and updated dispatch protocols
- Safety, ethics, and data privacy training
- Cross-training for interdepartmental coordination

5. Indirect Costs – \$700,000

Estimated at ~18% to cover facilities, procurement, audit, and administration costs across
Shawnee County departments engaged in the project
